NOTIFICATION

Following amendment to the Recruitment Rules (Non-Teaching Employees) 2020 is notified herewith for the information of all the stake holders.

This has reference to the Clause 6 (ix) to Recruitment Rules (Non-Teaching Employees) 2020. The amendment to be implemented is as follows:-

	Existing	Amended
Clause 6 (ix)	<p>Not with standing any other provision of these rules, where there is no person with minimum number of years of service available in the feeder grade, for the post to be filled through promotion and it is not desirable to keep the post(s) vacant, such post(s) may be filled on Temporary Promotion/Deputation/Short term Contract/Direct Recruitment basis in the following manner:</p> <p>i) If there is a candidate in the feeder cadre, who is eligible as per the requirement prescribed for direct recruitment for the post, the post may be filled on temporary promotion basis for a period not exceeding two years depending upon operational requirement or till the post is filled on regular basis, whichever is earlier.</p> <p>ii) If there is a likelihood of eligible candidates becoming available in the feeder cadre, in the succeeding one year and there is no likelihood of an additional post falling vacant in that period, the option of deputation/short term contract may be opted.</p> <p>iii) If there is a likelihood of eligible candidates becoming available in the feeder cadre in the succeeding one year and there is likelihood of additional posts falling vacant in that period, the option of Direct Recruitment may be opted.</p>	<p>Not with standing any other provision of these rules, where there is no person with minimum number of years of service available in the feeder grade, for the post to be filled through promotion and it is not desirable to keep the post(s) vacant, such post(s) may be filled on Temporary Promotion/Deputation/Short term Contract/Direct Recruitment basis in the following manner:</p> <p>i) Deleted.</p> <p>ii) If there is a likelihood of eligible candidates becoming available in the feeder cadre, in the succeeding one year and there is no likelihood of an additional post falling vacant in that period, the option of deputation/short term contract may be opted.</p> <p>iii) If there is a likelihood of eligible candidates becoming available in the feeder cadre in the succeeding one year and there is likelihood of additional posts falling vacant in that period, the option of Direct Recruitment may be opted.</p>
