## SARDAR KARTAR SINGH GROVER MEMORIAL MERIT SCHOLARSHIP

- There shall be a scholarship known as "Sardar Kartar Singh Gorver Memorial Scholarship\*" to be awarded out of the annual income accruing from the interest of Endowment of `50,000/-(Rs. Fifty Thousand) endowed by Prof. P.S. Grover, Department of Computer Science, University of Delhi, to the University, in the memory of his father, Shri Kartar Singh Grover.
- The Scholarship shall be of the value of `*350/- per month.\*\** The scholarship shall be ordinarily tenable for an Academic Year from August 1<sup>st</sup> of a year to April 30<sup>th</sup> of the next year (Nine Months); extendable to the next academic year.
- 3. The Scholarship will be awarded to a student of Computer Science courses, BCA or B.Sc. (H) who secures highest marks in the First Year Annual Examination of the BCA B.Sc. (H) course. The student must have secured at least 60% marks in the first year, (two semester combined, if the examination system is semester based) and pursue his regular studies in the second year of the BCA/B.Sc. (Hon's) Course
- 4. In case, two students secure equal number of marks in the first year, then merit is to be decided by the rank of the student in the entrance test, if the admission to the course is by entrance test. (In case, the admission is based on the class twelfth result, then the student getting higher marks in class 12<sup>th</sup>, would be awarded the scholarship).
- 5. The scholarship shall be extendable for the next Third Academic year of the course, if the scholar in the Second year BCA/B.Sc. (H) Examination secures at least First Division 60% marks.
- 6. No student shall be eligible for the award of this scholarship if he/she already holds a scholarship awarded by Delhi University or any other University or the Central Government or any State Government or Private Body, other than freeship. In case any scholar accepts any other scholarship/financial assistance salary from any other source, he/she shall be required to refund the amount received by him/her on this account from the date he/she accepts the other scholarship/financial assistance.
- 7. In case the student securing the highest marks in the First Year Examination is unable to accept the scholarship, the same shall be awarded to the next student strictly by merit. Merit is to be considered for the BCA+B.Sc. (H).
- 8. If it should appear at any time during the tenure of the award that the scholar has failed to make satisfactory progress or has been found guilty or gross misconduct or has been irregular in attendance he/she shall, after due warning, in writing, be reported by the Principal of the Institution to the Academic Council which may suspend or withdraw the scholarship.
  \*Taking combined merit into consideration.
- 9. The scholarship shall be awarded by the Academic Council on the commendations of Selection Committee constituted as follows:-
  - (a) The Dean, Faculty of Mathematical Science (Chairman)
  - (b) The Head, Department of Computer Science
  - (c) Prof. P.S. Grover (Donor) or his nominee with the approval of the Vice-Chancellor.
- 10. Applications for the scholarship, in the prescribed form obtainable from the office of the Registrar (Scholarship Cell) should reach the Registrar, University of Delhi, Delhi – 07, through the Principal of the Institution concerned by the date mentioned in the notification issued by the Registrar, in this behalf.
- 11. The payment of the scholarship amount shall be made to the scholar through the Principal of the College from August each year on presentation of a certificate to the effect that during the period covered into the bill, the scholar was net in receipt of any scholarship/financial assistance from any other source.
- 12. The unutilized amount in any year shall be added to the corpus of the endowment fund.
